SOMEWHERE in Dublin a 14-year-old girl is not only suffering the trauma of rape—but she also

has to face the barbarism of the Irish state.

was in office for only a few days and he decided to spend his energies hounding a 14-year-old girl.

This staunch Fianna Fail supporter who was an active member of the Catholic Marriage Advisory Bureau, is nothing but a thug.

When Larry Goodman was swindling EC grants, Fianna Fail attorney generals were not so quick to slap injunctions on him.

When Haughey's friend Dermot Desmond was trying to hide his property scams in taking over the Ballsbridge site of Johnson Mooney and O'Brien, there were no court orders forcing him to reveal his front companies.

But when it comes to the treatment of Irish women it's a different story.

It is high time to put a stop to this return to barbarism. No fourteen-year-old can be condemned by the Irish state and watched by the Irish gardai to make sure that she becomes a mother.

IN the light of the injunction served against an innocent 14-year-old rape victim, the 1983 Amendment to the Constitution has been revealed for what it is: a vicious attack on the right of women to have control of their own bodies.

Nor should we be under any illusion that the forces responsible for initiating the Amendment, SPUC, LIFE and their ilk, were not acutely aware of what it might lead to.

William Binchy, a leading member of LIFE and chairman of the Pro-Life Amendment Campaign (PLAC) made it clear in a statement given on RTE shortly after the story of the present case broke that the serving of the injunction restraining the girl from seeking an abortion in England was the logical result of the 1983 Amendment.

The response of people such as Binchy and Dr Mary Lucy—president of SPUC—to the dreadful

plight of an innocent fourteen year old girl makes plain their total disregard for the right of women to control their own

If any doubt remained about what all this meant in regard to the legal status of women in Ireland it was made crystal clear in one of Judge Costello's com-ments at the High Cout hearing on February 17.

Suicide

When informed by a psychologist that the fourteen year old might attempt suicide rather than carry the pregnancy to term, Judge Costello said that such a danger "Is that such a danger "Is much less and is of a dif-ferent magnitude than the certainty that the life of the unborn will be terminated".

As far as the law in Ireland is concerned, the life of a foetus is of greater importance that that of its mother.

It is now beyond doubt that the consequence of the 1983 Amendment is to the 1983 Amendment is to make a mockery of the notion that any individual freedom for women exists in this country. The present injunction and the "pro-life" Amendment represent an unacceptable infringement of basic civil liberties and the right of liberties and the right of free choice for women.

Now, more than ever, it is vital that we defeat the Now, more than ever, it is vital that we defeat the hypocritical moralism of groups such as SPUC and the church who claim to be pro-life and yet are in fact set on turning Irish women into second-class citizens in their own country.

In their own country.

To do this we must fight the injunction tooth and mail, and also campaign to repeal the 1983 Amend-ment to ensure that more such tragedles do not befall women in the future.

We must also be clear that to make a campaign successful, questions being asked in the Dall are not enough.

It was only through people taking to the streets in protest that the case of the fourteen year old was brought to the centre of public attention.

We must learn from this example. If SPUC and LIFE are not to be let away with this shameful intimidation this shameful intimidation of women it is vital that we continue to hold mass demonstrations. Those concerned in fighting the bigotry of church and state should set up "Scrap the Amendment Action Groups" in their own area or join those already established. It's only through this sort of action through this sort of action that we can best support the unfortunate victim of this injustice and defend the rights of women in this country.

Abortion: A women's right to choose

ANTI-abortionists claim the unborn has "an equal right to life" with the mother. This is nonsense. The foetus is merely a potential human being. It cannot, up to certain point, exist outside the woman's body—it is dependant on her.

What the SPUCists want to enforce is the "right" of the foetus to exist inside a woman's body against her

That is why we insist that the woman, her right to control her own body, her health and wellbeing must come first. To deny a woman the right to choose is to devalue her, her life, her relationships, her hopes and aspirations.

aspirations.

We insist each pregnant should have the right to decide her own destiny.

decide her own destiny.

This is a political issue because at the moment, that decision is made for her by the church and state, by the politicians, clergy and judges.

It is also a class issue. Working class women are far less likely to have the money for travel to Britain and to pay for an abortion. Their access to advise and counselling on all aspects of pregnancy is virtually non-existent.

The rich, on the other hand, are well able to afford the fees of private clinics in Britain and travel expenses.

If women are ever to be liberated they must win freedom from the chains that

keep them in the home. The single biggest chain is lack of control over their own fertility. If cheap, reliable, safe contraception was freely and widely available, a great step to this freedom would be made.

But even the most reliable contraceptive—the Pill—has side effects; other forms of contraception are more risky. This combined with the denial of abortion rights,

means many women have little or no choice as to whether or not to have children.

The provision of free abortion on demand would therefore be a great stride towards women's liberation. The first step on this road must be the repeal of the amendment which denies women the right to make their own choice.

SPUC: Smug satisfaction in the face of suffering

THE only people drawing any satisfaction from the current case are SPUC, Family Solidarity, and the "Responsible Society".

They united in 1983 to form the Pro-Life Amendment Campaign (PLAC), with the aim of ensuring that abortion would never be available in this country.

The recent injunction shows how horribly successful they have been. For all their po-faced statements of concern for the 14-year-old girl, they are still determined that no Irish woman will be allowed to have an abortion.

The people behind SPUC are not simply citizens concerned about the "the right to life of the unborn". They fight every attempt to allow freedom in sexual matters. All around them they see a conspiracy to subvert the family, the Church and private property.

Not content with their victory in the amendment in 1983, which copperfastened the ban on abortion in this country, they succeeded in stopping the Open Door centre and the Well Woman centre from referring Irish women for abortions in Britain.

They hounded students who published abortion

information, dragging them through the courts and getting more injunctions. They have succeeding in getting women's health books removed from public libraries.

So far SPUC have been winning in their campaign of legal intimidation and censorship. But they can be

Freedom

When the Brook Centre announced plans to set up a clinic in Belfast to offer advice and information on sexual matters to teenagers (including information on abortion) SPUC vowed to stop it. They collected together Catholic and Protestant bigots to halt the opening.

opening.

But they didn't get things there own way. The Socialist Workers Movement took the initiative to form the Campaign for Information and Choice. This campaign mobilised people on both sides of the sectarian divided, Catholic and Protestant, trade unionists, academics, students, women's rights and gay rights activists which forced Belfast City Council to support the Brook Clinic.

A similar campaign is needed in the South to smash SPUC's sectarian, anti-abortion amendment.
