While Irish workers pay some of the high-est rates of tax in Eu-Ireland's rope, bosses refuse to pay even the low rate levied on them.

The Government, High The Government, High Court inspectors and Revenue officers have a list of 120 Ansbacher tax cheats in the golden circle. They include some of the country's leading business figures.

They used fraudulent

They used fraudulent accounts set up by Des Traynor and his associates to launder hundreds of millions of pounds for Irish industry bosses and politicians.

Traynor was a close associate of disgraced former Taoiseach Charles J Haughey. It was Traynor who helped organise the finance from big business that allowed Haughey to live the life of a country squire in return for favours for Ireland's rich.

Until he died in 1994 Traynor was also boss of Ireland's largest indusrelato's largest mous-trial concern Cement Roadstone Holdings. In CRH's swanky offices in Dublin, Traynor ran an il-legal secret bank to allow Ireland's Golden Circle to milk the system. Over half of the direc-

The 'back to back' scam

"Back to back" loans allowed Ireland's rich not only to escape paying tax on their wealth, it also allowed them to claim tax deductions on it.

Here's how it worked.

A millionaire would place some of their wealth in the Ansbacher accounts. This money was held in secret coded accounts in the Cayman Islands.

The deposit was not declared and the interest earned escaped tax.

But that was not all.

The deposit was then "lent" back to the original lender so the money could be re-invested at a profit.

This loan was declared and the interest paid on it was offset against the individual's overall tax liability.

So not only tax on the wealth evaded but tax re-lief could be gained by one person effectively lend-ing the money to himself.

In this way hundreds of millions were ripped off while nurses were told the country could not afford to pay them adequately.

he held deposits in the Ansbacher accounts.

Barry is a central figure among Irish businessmen. Not only is he boss of CRH but he is a past president of employers' group IBEC and has also been a director of sugar company Greencore, industrial holdings company DCC and Bank of Ireland.

CRH director and former Irish Life chief ex-ecutive Bob Willis has refused to deny having deposits in the accounts. Dr Michael Dargen of CRH and formerly boss of Aer Lingus has admit-ted links with Ansbacher.

Instead the government

is taking extraordinary measures to ensure the names of the 120 do not leak out.

leak out. In contrast those ac-cused of stealing minor items from a supermarket have their names routinely published.

Taoiseach Bertie Ahern even went so far as to make excuses for these fraudsters when he said last week:

"The pressures of the eighties meant there were people strapped for cash. People were finding the

People were finding the devices and the means and people did not care about paying their share."

The people who were and are really "strapped for cash" are workers on low pay, PAYE payers and the unemployed. These are the people whose pockets the Golden Circle have picked so they can

have picked so they can live in luxury.

The Ansbacher frauds should be named, jailed and their wealth taken from them.

Former Dublin City and County Assistant Manager, George Redmond, received gifts totalling 35 times his official salary. These "gifts" were from builders and others seeking planning permission "advise".
And now the government sits on the names of 120 captains of industry, millionaires and politicians who

participated in the Ansbacher fraud. Perhaps they will be forced to throw a small number to the wolves, but they still hope to limit the impact and protect themselves

It's about time working class people fought back and took the wealth of these parasites.

The nurses, for example, should be supported in their fight for decent wages.. And other groups of workers should join the pay revolt.

But we need to go further and fight for a society where

there are not these obscene concentrations of wealth in private hands while public services are run down.

We need to fight for a socialist society where working class people democratically control the wealth and organise for human need not the foreign bank accounts of the millionaires.
