John Monks, General Secretary of the ETUC, said that 'Social Europe is under threat along with the national collective bargaining and welfare systems of individual member states.

Attempts

'There are widespread attempts by Governments, including those of the Centre left to, weaken welfare unilaterally and privatise public services...'

The call follows mass protests in many European countries over issues like 'pension reform.'

These are usually proposals for workers to work for a longer period of their lives to make up for the fact that employers speculated with their pensions funds and lost billions on the world stock exchanges.

The ETUC call for action needs to be taken up by the Irish trade union movement. Bertie Ahern and Mary Harney say they want to use the EU Presidency to push the 'Lisbon agenda'.

Harney has explained that this means a 'a business environment in which enterprise can prosper, in which regulatory burdens are eased'.

production rose again in November last year when it was running at almost 16 per cent ahead of the same month in 2002.

But while workers may be more productive many more of us are being made redundant!

In 2003 there were 27,700 redundancies the highest number in 19 years!

According to the Irish Times "Indigenous industry WHILE the Fianna Fail/PD government slash spending in both health and education they have found some spare cash to spend on a new weapon system for the Irish army!

In fact it is the single biggest military purchase in the history of the Irish state.

The United States government and the giant American arms company Raytheon/ Lockheed-Martin earlier in the month said that they "were very pleased" that the FF/PD government had bought the missile system.

FF/PD have bought the Javelin anti-tank guided missiles. The US Congress approved the sale of the Javelin, which saw some combat service in Iraq.

Overall the sale will be worth \$26m to the US manufacturers and government.

Raytheon Lockheed Martin

has a plant in Derry and issued a statement last week highlighting the deal following demands from Derry City Council.

The company assures them that its plant in Derry is not involved in the production of any form of military hardware or software.

Raytheon claim that their Derry workers are not involved in any direct military manufacturing!

Protests

There were also protests in Derry's Guildhall Square last

week by anti-war activists.

Ominously the sale requires a US government and company team to remain in Ireland for two years to assist in the delivery and deployment of the missiles.

The Irish army is becoming increasingly militarised by the Irish government in preparation

for its role in any future European army and its continued role within the NATO organised Partnership for Peace.

Combined with the continued use of Shannon Airport by the US military Ireland's relationship with NATO grows ever closer.

Irish economy one of the most neo-liberal in the world

IRELAND is still the fifth most privatised and 'open' economy in the world.

According to the 2004 Wall Street Jour-

nal index Ireland's 12.5 per cent corporation tax "beats the EU average of 30 per cent by a wide margin."

Ireland only comes in behind Hong Kong, Singapore, New Zealand and Luxemburg in the

table. Ireland even beats countries like the United States and Canada when it comes to having a neo-liberal globalised

economy.

No doubt this fact will be celebrated by Ahern and Harney but try telling workers such as those in Trerton Sport Ltd in Portlaois that it is a good thing.

Some 68 jobs have been lost at the company as Tretorn Sport have decided to relocate their tennis ball manufacturing company to the Far East to increase their profits.

Bush admits there were no WMDs

THROUGH his own actions Bush has finally proved beyond any doubt what those of us who were against the war always knew-there were no weapons of mass destruction in Iraq.

The Bush administration has quietly withdrawn its 400 member team it sent to Baghdad to scour Iraq for evidence of WMDs.

The team that was known as the Joint Captured Material Exploitation Group has now been quietly disbanded by Bush, thus acknowledging that the weapons issue was just an excuse to invade Ĭraq.

While Blair still talks about finding these weapons Bush has quietly admitted that no such weapons exist in Iraq and has abandoned the sham search.

WHILE supporters of the invasion of Iraq argued that the capture of Saddam Hussein would lead to the melting away of Iraqi resistance events on the ground have proved them wrong.

And you only have to ask Britain's 'top envoy' in Iraq Jeremy Greenstock. Speaking to reporters' just hours before Blair's visit to Iraq Greenstock said that the resistance was growing despite Saddam's capture.

NO TO A NEO-LIBERAL EUROPE No to Brennan's Privatisation Onslaught

AS the Irish Presidency of the EU begins the privatisation onslaught at home also began in earnest.

The Minister for Transport's warning to the unions in Dublin Bus and Aer Rianta that they would have to face up to "inevitable changes" brought instant reaction from union members.

Workers knew that this was political spin for "privatisation". Brennan is one of the most ideological members of the cabinet and is hell bent on breaking up Aer Rianta and the privatisation of a high number of Dublin Bus and CIE routes.

An angry meeting of 250 SIPTU members mandated their officials to prepare for strikes to disrupt Ireland's presidency of the EU.Aer Rianta Worker Director Peter Dunne said the action could disrupt foreign dignitaries arriving for an EU meeting in Dublin on 22 and 23 January.

Talks

As Socialist Worker went to press the union leadership had decided to reenter talks with Brennan and strike action had been called off in the short term. However Brennan and the FF/PD government are wedded to their neoliberal agenda which is mirrored in the polices of the EU.

Brennan continues with his privatisation push despite the fact that a government commissioned Pricewaterhouse Cooper study said that Dublin Bus was one of the most efficient and least subsidised services in Europe and that the break up of Aer Rianta would make "no economic sense".

In 2002 Dublin Bus made a profit of 3.4 million. This was the result of the huge efforts of the staff. The bus service was traditionally run down by various governments, particularly during the Haughey years of the late eighties.

At one point the state subsidy for Dublin Bus was cut from an annual subvention of $\pounds 24$ million to a miserly $\pounds 5.6$ million.The result was that in 1995 Dublin Bus came close to all-out bankruptcy. Since then state policy has changed and after 1999, the annual subvention grew massively.

The government figured that it was in the wider interests of Irish capitalism to have more buses on the streets to get people to and from work. Dublin Bus workers also agreed to major efficiency changes-giving seven productivity deals in recent years.

Declared

Shortly after taking office in June 2002 Brennan declared that one quarter of Dublin's bus routes would be operated by private companies. He now wants to see this happening by May this year. In December last year he also said that Bus Eireann would see one-quarter of its routes opened to competition.

This right-wing drive towards pri-vatisation by Brennan is part of the wider EU agenda of implementing neoliberal policies in the member states.

The proposed new EU constitution prepares the way for privatisation of health and education services as part of the Common Commercial Policy. To add to this the Constitution extends the powers given to the European Commission by Article 133 from the Nice Treaty in relation to the promo-

tion of liberalisation, privatisation and deregulation. This will allow the Commission to push through the WTO agenda of privatisation and deregulating of all our public services.

What is happening in Dublin Bus and Aer Rianta is just one part of a

broader European picture that can be summed up in two words-corporate globalisation.

Across Europe the top multinationals want to turn every aspect of our lives into a commodity they can make profit from.

They push the mantra of 'de-regulation' and 'competitiveness' in the corporate media that they control. But in the end privatisation only works against the majority of people and benefits the rich.

In Britain transport privatisation has brought increased bus fares, which have gone up 87 per cent in real terms since 1974. It has also lead to a worse off peak and evening service.

The Director of Transport 2000 says they are infrequent at times when companies reckon they can make less profits.

Workers in Dublin Bus, CIE, and Aer Rianta are at the forefront in the struggle against privatisation and the neo-liberal agenda that our bosses and governments are pushing right across Europe.

Their struggle is all the more important in this time of Ireland's EU presidency



A year ago there was some media speculation that the owners of the Ansbacher Caymen bank would have to foot a bill of up to $\in 100$ m because of their involvement in the tax scandals.

Garda Abuse: Not news to working class Garda interacted with people his arrival in prison the follow-

THE recent Prime Time programme that focused in on the activities of the Irish Gardai would not have come as much of a surprise to many working class people.

The widespread abuses and perjury detailed in a television programme have led to much media talk about the "tiny numbers of Guards" involved in such practices.

However in many working class communities in Dublin and in other cities across Ireland the problem is not with just individual Gardai but with

the force as an institution. A conservative politicia who lived in working class areas of his constituency.

Interestingly many of the incidents of Garda brutality chronicled in the Prime Time programme happened to middle class people.

Roughed Up

Many working class people who have been 'roughed up' by the Gardai or who have a complaint about the force never even bother reporting such incidents. The Garda Complaints Board has proved to be a joke and Minister McDowell is dragging his feet on introducing protestors two years ago, Abbey-lara, and the investigations into Garda corruption in Donegal have thrown more light on the workings of the force.

According to a report produced in September by the European Committee for the Prevention of Torture and Inhu-

One of the allegations in the report said that a person interviewed by the committee in Cork prison alleged that four or five police officers dragged him down the stairs at the Anglesea Street Garda station in Cork

prison the prison doctor noted 4 fresh marks on back, prior to committal'.

In another incident in Cloverhill prison a person alleged that at the time of his arrest a garda had twisted his arm. Subsequently at Store Street Garda station a garda had struck him on several occasions with a baton on the head, blows which he deflected by raising his arms.

Examined

Although the doctor who examined him at the Garda station five hours after his arrest found only handcuff marks on his right wrists and as part of the general struggle injection marks on his lower arms, the medical screening on

ing morning found 'superficial haematomas and contusions on the lower left arm'.

While socialists should call for the greatest accountability as possible over the actions of the Gardai, in the end a post such as a Garda ombudsman would not solve all the problems.The Gardai are part of the capitalist state and thus in the end carry out the function of protecting the status quo and those at the top.

A truly democratic policing force reflecting the wants and needs of working class communities could only come to pass against capitalism and the fight for socialism.

Bush set to collect the peace dividend

CAMPAIGNERS against the arms trade scored a victory in Derry at the beginning of January when the city council passed a res-olution condemning the global arms industry and instructing the town clerk to write to Raytheon for confirmation that no military equipment is being produced at its Derry plant.

Raytheon, the third-biggest arms manufacturer in the world, was introduced to Derry five years ago by Nobel Peace Prize winner John Hume. Both Hume and fellow 1998 Peace Laureate David Trimble cited the arrival of the company as evidence of a "peace dividend"

The glaring irony helped focus attention on the company's start-up in Derry. The Foyle Ethical Investment Campaign (FEIC) was the result. FEIC led a dogged, imaginative campaign which culminated in the special council meeting and resolution.

Although the SDLP and Sinn Fein supported the FEIC motion, their position wasn't clear-cut. Both parties said they'd want Raytheon out if it was discovered armaments were being produced in Derry. But they accepted Raytheon's assurances that this wasn't so. FEIC doesn't take Raytheon's word, but didn't highlight this difference on the day. The motion was "as much as we could have hoped for," said a spokesperson, adding that the council vote had confirmed "the integrity of the peace process".

Boasted

However, on the same day, January 7th, news came from Tuscon, Arizona, which threw light from a different angle on what's at stake in the Raytheon issue and put a question mark against "the integrity of the peace process:" Raytheon announced that the Irish Government had ordered a batch of its Javelin anti-tank missiles.

The Javelin, boasted the company, is "the world's first, one-man-transportable fire-and-forget antiarmour missile system. It saw extensive use by US and allied soldiers, marines and Special Forces in Operation Iraqi Freedom. Javelin is approved for international sales through the US Army's Foreign Military Sales System.'

The last sentence is key. The Javelin is a hightech state-of-the-art weapon which can only be exported after the US Army has scrutinised the sales contract and approved both the purchasing government and the purposes to which it's intended the weapon will be put. The Dublin deal, said Raytheon, "the first sale (of the Javelin) to a neutral, non-aligned nation," would "provide the Irish Defence Forces with a highly effective means of deterrence in front-line peace-keeping missions, (allowing) a single soldier to defeat all known armoured vehicles."

Clearly, Southern Ireland is now seen as a State which can be counted on to make no move which the US military might disapprove of. The "front-line peace-keeping missions" will be such as to meet US approval. "Neutral and non-aligned" the South might be, but neutral and non-aligned on a particular side.

It was this development announced in Tuscon, rather than the passage of the resolution in Derry Guildhall the same day, which was the more significant for understanding the "peace process."

THE sickening racist attacks that made headlines in the North in the last few weeks were not random acts of violence by a few mindless thugs.

They were the orchestrated act of loyalist paramilitary groups who have a long-standing relationship with far right Nazi groups such as the BNP and Combat 18.

The majority of racist attacks in Northern Ireland never make the headlines.

Recorded figures show that on average every

We know from NGOs that if we add together everyone who has ever been granted asylum here plus those awaiting decisions on their applications, it comes to less than 3,000.

Levels of poverty in

the North are worse than any other part of these islands.

The lack of public services and resources for working class people is appalling and there is intense competition for housing, health, leisure and other services.

Overt sectarian scapegoating has become less acceptable in working class areas, if not at politician level.

Loyalist paramilitaries, forced to reduce their attacks on Catholics, are turning on the minority ethnic community instead.

The truth about asylum seekers

Welcomed

The Dublin Government, the SDLP and Sinn Fein have all warmly welcomed the US as arbiter and supervisor of the peace process. It's commonly suggested that the US has undertaken this role selflessly, that there's nothing in it for Washington, that it has no implications for attitudes to US power generally. Sinn Fein leaders in particular maintain that they can work with the Bush administration as allies as far as the Agreement is concerned, while opposing US empire-building elsewhere.

But it's a nonsense to imagine that the relationship which has developed between the US and Ireland with regard to the peace process is entirely separate from the developing relationship illustrated in the Javelin deal.

From the point of view of Bush, Powell etc., Raytheon's deal with Dublin represented another little fragment of the New World Order falling into place—all the more neatly on account of the peace process.

There's a peace dividend alright, paid out in political influence, and presently being pocketed by George Bush.

These attacks range from spitting and verbal physical abuse to assault.

Racism is on the rise in Northern Ireland for a number of reasons.

The racist abuse and lies heaped on asylum seekers by politicians and the press is undoubtedly the main reason

The fact that Europe's leaders dishonestly refer to asylum seekers flooding the area encourages people to think that anyone who isn't European looking is an asylum THE authorities in Northern Ireland are abusing asylum seekers.

Despite a European ruling against Blunkett's plans to deny all assistance to anyone not claiming asylum imme-diately, this is what happens in most cases.

People arrive here after long arduous journeys, don't speak the language, don't know the rules, and are often terrified.

Yet, they are expected to announce at the airport or docks where they

first land that they want to claim asylum.

Only if they do this will they receive a meagre £38pw to live on.

Out of this they will have to spend almost £10 every week travelling to Aldergrove Airport to sign on with immigration.

Denied

They are denied the right to work but can be housed by the Housing Executive, which seems to have a policy of plac-ing them in the most dangerous areas.

In a number of cases, asylum seekers have been housed in properties vacated during the loyalist feud.

If they break the rules in any way their claims are withdrawn, they are moved to Maghaberry and they are deported.

If they accidentally cross the border the same applies.

In the vast majority of cases where they comply with every petty rule and ritual humiliation, they are still refused, detained and deported.

Extreme poverty

often forces people to live in overcrowded conditions with others in similar circumstances.

Entitled

The families forced out of their homes at Christmas were denied help by the Housing Executive because they were "not entitled to it".

If the Balmoral Hotel had not offered accommodation to the Chinese couple whose first baby was due within days of the attack on their home, they would have spent Christmas in prison.

British soldiers kick Iraqi prisoner to death

BRITISH soldiers in ripped off his wrists Basra kicked father of two, Baha Mousa, to death while in their custody.

Baha was the son of an Iraqi police colonel and the last time his father saw him was when he was lying with seven others on a marble floor in the Haitham Hotel with his hands on his head under the guns of the British army.

'Three days later, I was looking at my son's body' Lieutenant Daoud Mousa said. 'The British came to say he had 'died in custody'. His nose was broken, there was blood above his mouth and I could see bruising of his ribs and thighs. The skin was

The eight prisoners were held in a building, which had formerly been the secret police headquarters of 'Chemical Ali'.

One of the surviving prisoners told the Independent on Sunday that their hands were tied behind their back and bags were put over their heads. Soldiers came in and 'were kickboxing us in the chest and between the legs and in the back. They set on Baha especially'.

Amnesty international have called for an independent investigation. But the British army offered the family \$3,000 in compensation and say they will only have an internal inquiry. The Mousa family has refused this and is demanding justice for their son.

"There are building regulations, but people are desperately in need of housing so the authorities overlook the code of building for earthquakes."

Costs of imports are driven up further thanks to the economic blockade of Iran imposed by the US over the last quarter of a century. And in pushing deregulated expansion, the Iranian government is merely following the prescription of the World Bank and International Monetary Fund.

It was exactly the same picture in Turkey, a key Western ally, when an earthquake killed tens of thousands of people in 1999.

similar story could be told of the Gujarat earthquake which claimed 30,000 lives in 2000 in India, a country whose rulers have developed nuclear weapons and backed Bush's wars while leaving half the population on less than a dollar a day.

And apologists for capitalist globalisation perversely seized on the tragedy to claim that fewer people would have been killed if Iran had a pro-Western government and a free market economy.

Guardian columnist David Aaronovitch claimed the fact that a similar quake in California a few days before killed only three people showed the superiority of neo-liberal capitalism.

In fact the appalling death toll in Iran is a product of the chaotic capitalist development championed by governments of every stripe the world over.

Tens of thousands of people died in the city of Bam quite simply because houses were thrown up using cheap materials with no enforced building regulations.

That is not unique to the Islamist regime in Iran. It is the

In 1988 it was Armenia, in 1985 Mexico City, in the 1970s Italy, Nicaragua, Greece and many others.

Today one billion people across the world live in shanty towns. Forty of the 50 fastest growing cities are located in earthquake zones. Already 58 percent of the world's refugees are fleeing from the consequences of natural disasters.

Rampant capitalism and its armed wing in the White House mean more disasters such as the Bam earthquake, and more restrictions on poor people moving to safety.

'THE LAST few years have weeks seen the revival of the movement in Egypt after a long period of stagnation

There were lots of spontaneous popular outbreaks in solidarity with the Palestinian intifada. or uprising, when it began in October 2000.

The movements reflected the economic and social crisis within society. The movements brought people back to the political scene and opened a window for people to act. This threw the regime into a bit of a crisis. It was facing a mobilisation that it was not strong enough to suppress outright.

Two years after that we witnessed a number of initiatives by different currents within the movements. They created a common space where people could work together on issues.

At the end of 2002, as the US anti-war activists. preparations for war on Iraq increased, campaigns against the war began to emerge. The left played a prominent role.

Activists got together to organise demonstrations of hundreds of people on the streets despite the security restrictions. There were six protests from December until war broke out. This helped to create space for a wider movement.

Demonstrate

The call went out that when the war began we would demonstrate in Tahrir Square, the most important part of Cairo.

On 20 March, the day the US attacked Irag, the wider population joined the movement. Tens of thousands of Egyptians took to the streets. This demonstration occupied Tahrir Square from noon to midnight.

The size prevented the security forces from suppressing it. It was a "freedom carnival". It was

unique for Cairo. I left the square that ing intensely optimistic. We were to protest the next day too. But the regime sensed the danger. It was determined to repress as much as possible so 20 March was not repeated. If we had succeeded there would have been a high possibility of a real intifada in Egypt.

From early in the morning the police started beating and arresting activists. There were tens of thousands there again. The police arrested 800 people. People were radicalised by the place in Egypt.' oppression.

The Mubarak regime has been called the most "despotic Egyptian regime since the French came in 1798". There are around 30,000 detainees in prisons without charge or trial. the last ten ver years EU governments to keep as many asylum seekers as possible out. As the number of wars and levels of poverty and disease increase outside of the "West", the EU has become more vicious in its desire to keep out the most needy and desperate people in the world.

Moves to harmonise asylum and immigration policies began in the early 1990s.

There were a number of nonbinding resolutions and two important treaties: the Schengen Agreement on common border controls; and the Dublin Convention which identified the first EU state entered as that responsible for assessing the asylum application.

The Amsterdam Treaty (1997) further advanced harmonisation with common criteria for dealing with applications, detention, reception, family reunification and deportation

US problems grow in Iraq

THERE IS a general consensus in the media that George Bush and Tony Blair entered 2004 in a much stronger position than seemed likely even a few weeks earlier.

The fundamental reason for this apparent shift is Saddam Hussein's capture, but the agreement announced with Libya ust before Christmas also helped.

The Libyan regime's declaration that it was now abandoning its efforts to develop weapons of mass destruction seemed to vindicate the obsession with WMD that Blair restated during his photo opportunity in Basra.

But Libya's programmes turned out, according to United Nation inspectors, to be pretty small beer.

Both Saddam's capture and the Libyan deal were at best propaganda victories for Washington and London. They didn't change the fundamental balance of forces. This was set out with admirable clarity in a two-part series in the Financial Times before Christmas called "The Dependent Superpower".

The first piece, by Martin Wolf, argued that American capitalism, although the chief agent of and beneficiary from economic globalisation, has also become more vulnerable as a consequence.

The US economy is much more heavily dependent on foreign trade than it was for most of the 20th century, and in particular on energy imports.

As Wolf puts it, "In oil and gas the US appears to be sleepwalking into ever-greater reliance on some unstable suppliers around the world."

Vulnerable

The US is also becoming more financially vulnerable. America imports considerably more goods and services than it exports

"This trade gap is financed by nuge foreign borrowing, particularly from the dynamic economies of East Asia. By the end of 2002 US net liabilities to the rest of the world had reached 25 percent of national income.

Wolf comments, "The era of the dollar standard may at last be nearing an end. Certainly exploding US liabilities to the rest of the world and Asian asset accumulation on the other side cannot continue indefinitely."

The second piece in the Financial Times series highlights the danger of "overreach'-that the US will take on too many commitments or find itself unable to withdraw from its many obliga-

occupations of The Afghanistan and Iraq and the confrontation with North Korea are already putting severe pressure on America's relatively small professional army. Michael O'Hanlon of the Brookings Institution says: "The US army could find some units deployed twice in a two to three year peri-

they can handle that. But by the time we have conclusive proof they may have broken the army.

Hence the eagerness with which, after going it alone into Afghanistan and Iraq, the Bush administration is now encourag ing other right wing governments to supply occupation troops.

In the case of Japan's Prime Minister Junichiro Koizumi this is in defiance of the country's paci fist constitution. But the pressure on the overstretched American military is unlikely to relent any time soon.

Seymour Hersh reported in the New Yorker just before Saddam's capture, "Inside the Pentagon, it is now understood that simply bringing in or killing Saddam Hussein and his immediate circle will not stop the insurgency.

A military analyst working for the Coalition Provisional Authority in Baghdad told Hersh, "Mid-ranking Ba'athists who were muzzled by the patrimonial nature of Saddam's system have now, with the disappearance of the high-ranking members, risen to control the insurgency."

On the ground the forces mounting resistance seem ver diverse politically.

The Pentagon's response according to Hersh, is what one adviser calls "pre-emptive manhunting" modelled on the Israeli Defence Force's campaign of 'targeted killings" and mounted by the kind of Special Forces unit that tracked down Saddam

Submission

"We're going to have to play their game," a Coalition Provisional Authority adviser told Hersh. "Guerrilla versus guerrilla. Terrorism versus terrorism We've got to scare the Iraqis into submission.

This language recalls other counter-insurgency wars-for example, in Algeria and Vietnam—where such tactics led to terrible atrocities and ultimate defeat for the occupier.

One thing shown by both the crowing over Saddam's capture and the ferocity with which the Pentagon is fighting the insur-gents is that the Bush administration understands how high the stakes are.

Its own political survival and the future of American imperialism depend on what happens in Iraq. Iraq is likely to continue to dominate world politics in 2004.

THE ZAPATISTA UPRISING TEN YEARS ON

NEW Year's Day 1994 and a peasant army of thousands of indigenous Mexicans staged an armed uprising in the southern state of Chiapas, taking over five towns including the state capital San Cristobal de las Casus.

The radical Zapatistas had burst onto the world's political stage proving those right wing thinkers who had been predicting the 'End of History' wrong.

Predating the 'Battle of Seattle' by some five years much of the anti-capitalist movement has been greatly influenced and inspired by the Zapatistas.

A decade on from their uprising KEVIN WINGFIELD assesses the past ten years and looks at the present state of the Zapatistas movement.



'Today we say Basta! Enough!'

N the same day as the uprising the North American Free Trade Agreement (NAFTA) came into effect.

NAFTA required tariff barriers protecting Mexican industry and agriculture to be dismantled, the removal of restrictions on foreign investment and the huge Mexican oil industry to be opened up to foreign ownership and privatisation.

The uprising was the work of the Zapatista Army of National Liberation (EZNL)!the Zapatistas. Their name harked back to the Mexican Revolution and Emiliano Zapata.

Zapata's peasant army had captured Mexico City in late 1913 for two months to prevent the landowners from stealing the revolution that promised land reform and peasant rights to the people of the country.

But in 1994 the promise of that revolution remained unfulfilled.

The corrupt Party of Institutionalised Revolution (PRI) had ruled virtually uninterrupted for 70 years, allowing the rich businessmen and big landowners to enrich themselves on the backs of the mass of the population.

Poverty

President Salinas had embraced neoliberalism and eagerly signed up with the US and Canada in NAFTA.

For the mass of Mexico's 90 million people poverty and inequality was a fact of life. Wages and social spending fell 40 percent in the 1980s and unemployment leapt to 24 percent.

NAFTA was set to make it even worse. At the very bottom of the pile fee and was the second largest produce of oil in Mexico as well as a burgeoning cattle industry.

The Revolution of 1910-17 had bequeathed a Constitution, Article 27 of which provided for the break up of the vast lands of the super rich and its re--distribution as communal holdings to the peasants.

But even the half-hearted measures introduced over the decades had been

frustrated by the landowners' and coffee baron's thugs backed up by the police and army.

Poverty

The scattered rural communities were under even more pressure when the government repealed Article 27 in 1992 provoking peasant resistance.

To defeat the Zapatista uprising of New Year's Day 1994 the government of Salinas unleashed a ferocious military assault on Chiapas.

The well-equipped government army faced a peasant army of people dressed in rags carrying only rifles (many of them made only of wood).

But within days Salinas was forced to call of the assault as hundreds of thousands of Mexicans flooded into the Zocalo, the central government square in Mexico City. The government again tried a year later to crush the EZLN but it was forced to enter talks with the Zapatista and their spokesperson Subcomandante Marcos.

The EZNL rejected the concessions offered as insufficient.

Since then between 25,000 and 60,000 troops have surrounded the EZNL in the hills of the Locandon jungle with frequent periodic assaults on the Chiapas population.

The Zapatistas and Anti Capitalism

THE Zapatista uprising was one of the inspirations behind the Anti Capitalist movement that arose throughout the world in the late nineties.

Here was an army of indigenous peasants standing up against the neoliberalism of structural adjustment programmes and the NAFTA and asserting their right to live free from the priorities of the multi-nationals and global capitalism.

"We are you," Sub Comandante Marcos declared to the world. "Marcos is gay in San Francisco, black in South Africa, an Asian in Europe, a Chicano in San Ysidro, an anarchist in Spain, a Palestinian in Israel, a Mayan Indian on the streets of San Christobal, a Jew in Germany, a Gypsy in Poland, a Mohawk in Quebec, a pacifist in Bosnia, a single woman on the streets of the metro at 10pm, a peasant without land, a gang member in the slums, an unemployed worker, an unhappy student."



but to ask for your help'."

Marcos declared, "I am a rebel, not a revolutionary!"

Although the Zapatistas could not expect to take and hold power throughout Mexico, it could easily find many allies among the country's population.

Shortly before the march, nearly a quarter of a million students in Mexico City had been on strike for over a year. But ideas like those expressed by Marcos meant there was no co-ordination between the indigenous peasants in the South and the students in the capital city.

Half the population officially live in poverty and 15 percent exist in extreme poverty. Mexico City with its 22 million inhabitants is the largest city in the world.

Would a call to these workers and poor to set up their own grassroots factory and neighbourhood committees and ally with Zapatistas in a revolutionary struggle against Fox and his regime have fallen on deaf ears? It's hard to believe so, but in any case the call was not made.

Is it possible to doubt that a massive movement in Mexico that aimed at overthrowing the state and organising to share the wealth fairly would not have found a mighty echo in Argentina, Bolivia, Venezuela and the rest of the boiling continent of Latin America?

were the country's 10 million indigenous people.

For them infant mortality was more than one in twenty.

As the Zapatista declaration of the time announced:

"We have been denied the most elemental instruction, in order thus to use us as cannon fodder and loot the wealth of our country without any care for the fact that we are dying of hunger and curable diseases; without any care for the fact that we have nothing: no roof worthy of the name, nor land nor work, nor health nor food nor education; without the right to elect our authorities freely and democratically; without independence from foreigners; without peace or justice for ourselves and our children.

"Today we say Basta! Enough!"

But among this poverty was great wealth. Chiapas produced half Mexico's hydro-electricity, exported the most cofThese ideas struck a chord throughout the world and inspired the anti capitalist movement. Naomi Klein, the author of *No Logo*, hailed the Chiapas uprising, and wrote a couple of years ago that they have become "theorists of a new movement, another way to think about power, resistance and globalisation. Zapatistas aren't interested in overthrowing the state or naming their leader, Marcos, as president. If anything, they want less state power in their lives.

"The goal is not to win control but to seize and build autonomous spaces where democracy, liberty and justice can thrive. Free spaces, born of reclaimed land, communal agriculture, resistance to privatisation, will eventually create counterpowers to the state simply by existing as alternatives."

But the question of power could not be solved as neatly as this.

Just as the anti-capitalist movement

Zapatista leader Subcomandante Marcos and (top) San Cristobal 1994

faces the question of the power of big business and the state machinery that promotes its interests, the Zapatistas are confronted with the power of the Mexican state that has been attacking it on all sides.

In fact when Klein wrote those words, the situation in the Chiapas hills was extremely difficult.

On and off talks with the government throughout the nineties had extracted an agreement—the San Andres Accords establishing local autonomy for indigenous peoples, educational, social and cultural rights and committing the Mexican government to eliminating "the poverty, marginalisation and insufficient political participation of the millions of indigenous Mexicans."

But the government had stalled and

ultimately repudiated the agreement.

Sympathy for the Chiapas movement was high among millions of Mexicans. In 2001 the Zapatistas organised a march across Mexico into the capital city. They were met by huge crowds of people in the cities and towns on the way. In Mexico City up to a million greeted them.

Support

Opinion polls at the time showed support levels for this insurgent indigenous peasant movement from the remote South at 50 percent, but the Zapatistas were not interested in taking government.

Interviewed last year by *New Left Review* Marcos told how during the march, "in every town square we told people: 'We have not come to lead you, we have not come to tell you what to do,

Today the Zapatistas have set up more than 30 autonomous areas in the remote Chiapas hillsides but are still encircled.

Many of these communities are dependent on the NGOs for their welfare. Last year Marcos announced that the negotiation process they were attempting to set up with the government had been fruitless and had called off talks.

Tragically, for all their hugely inspiring heroism and the clear justice of their demands, the EZLN and the autonomous areas of Chiapas are now hemmed in on all sides by the Mexican army.

The best tribute we could pay to their sacrifice is to fight against capitalism in our own countries, understanding that this will involve working class people breaking the power of the capitalist state and taking power.

THERE are two very different Marxist schools of thought on Lords of the Rings.

One is that the book and the film have a fundamentally conservative message since the model of a happy life in the books is the Shire, a romanticised, pre-capitalist, village based community.

Since socialists anticipate taking over modern means of production, the argument goes, then the kind of backward looking yearning for an imagined idyllic past promoted by the story is reactionary.

The other view is that the politics of the Lord of the Rings are essentially positive from a socialist point of view.

Not only because the growth of Sauron's power and its potential to plunge the world into darkness seems to echo the threat of fascism in the 1930s, but also because the real hero of the story is Samwise Gamgee, the most modest and indeed proletarian of the characters.

When all the high politics is said and done, it is the staunch loyalty and comradeship of Sam that makes all the difference to the fate of the world.

So the Marxist jury is out, but there is no doubting the verdict of the population of the developed countries of the world, who are buying the book and DVD's in record amounts and who are keeping up cinema attendances.

What is the appeal of Lord of the Rings? For a start there is no doubt that the book is a work of genius, far surpassing all other fantasy epics (which invariably have "the greatest fantasy writing since Tolkien" on the back cover).

Despite its length, the Lord of the Rings is just the tip of an iceberg. Tolkien was a professor in Old English and used his knowledge of language and pre-feudal northern European society to create an immensely intricate and consistent world. He was in complete and conscious control of his vocabulary, each name weighed carefully for its connotation.

To give just one illustration, Tolkien uses the word "wight" for a certain type of creature, neither alive nor dead, which is exactly how the word was used in sixteenth century Scottish poetry.

To read the book is to enter an utterly convincing world, a world with a history, one in which you feel that if you were to explore different corners of it, there would be no danger of it unravelling, but instead more and more detail would emerge. If you want escapism from your books, and millions do, then this is as good as it gets.

The other great strength of the book is that it has an intrinsically interesting dramatic device, a ring which grants the wielder immense power, but at a price

It will twist your actions towards evil, towards Sauron. The question posed by the existence of this ring to every character who meets it, is how will they react.

The weaker characters fool themselves into believing they can use it safely, the stronger fear it and knowing themselves, avoid contact with it, and the strongest of all?

They draw on their love of gardening and beer and do their best to ignore it. You cannot trust anyone with absolute power, but if you had to, you would offer it to the least political person in the world.

Thirdly, like George Orwell's 1984, written at a similar ne, the book holds up the possibility that the world can sink utterly into devastation and oppression. This is a prospect that remains plausible in a world threatened by instability in the form of war and environmental catastrophe. Our own fears are used to make the characters' fears genuine. And Gandalf in the film says something very interesting to Frodo: when the hobbit sighs with regret that he is alive in such dark times, the wizard replies to the effect that "hobbits make history, but not in circumstances of their own choosing." But unlike 1984, where love itself can be shattered under the right conditions, in *Lords of the Rings* comrade-ship is what means the juggernaut of terror can be derailed.

DURING 2003 the American media group Clearwater, which owns 11 percent of all US radio stations, banned the Dixie Chicks from its play lists because of their anti war stance.

Clearwater also used its network of affiliates to whip up pro-war demonstrations to counter the anti war movement in the USA.

Noam Chomsky has relentlessly attacked the US media for distorting and lying about Bush's war in Iraq.

He pointed out that polls indicated that a majority of US citizens had been persuaded of the absurd claim that Saddam Hussein was responsible for 9/11, despite not a shred of evidence.

Of course the media is not as powerful as is often claimed.

As Michael Moore has pointed out polls indicate that a majority of people in the US are pro-choice, favour living wage legis-lation and support support increases in spending Medicare and Welfare.

The fact that this is kept hidden owes as much to the agenda of the mainstream media as it does to the Shock-Jocks and Right Wing cable channels that have proliferated in recent years.

Al Franken is a leftleaning US stand up comic. His latest book, *Lies And The Lying Liars* Who Tell Them, is a best seller in the USA and attacks the Republican Right and its media supporters.

In particular he singles out Rupert Murdoch's Fox network for attack. With humour, he explodes their lying agenda and bullying style.

Much of this is very funny. Unfortunately (or fortunately) many on this side of the Atlantic will be unfamiliar with the columnists and TV presenters he attacks.

Fox tried to halt publication of the book, saying its sub-title, "A Fair and Balanced Look at the Right" infringed their copy right on the words "fair and balanced"!

Weakened

With researched examples, he demonstrates how conscious distortion, half-truths and barefaced lies are the stock in trade of the Right and its media hacks.

But Franken's book is considerably weakened by his politics. For him Republicans are bad guys and Democrats,

particularly Clinton and Gore, are the good guys who never got a square deal from the media.

For example, the Right accuse Clinton of neglecting anti-terrorism and US defence and were therefore indirectly culpable for 9/11.

Franken retorts with a defence of Clinton, citing his attacks on Somalia against "Al-Qaeda targets".

Convention of the Left to meet in Derry

A CONVENTION of the Left is to be held in **Derry on February 14th** to discuss a united Left slate in the June 2004 European election.

The convention is being organised by the Socialist Environmental Alliance (SEA) and is open to anyone who is for a social Europe and against a neo-liberal Europe, while refusing to be part of either nationalist or unionist camps in the North.

In its invitation to the Convention, which it is circulating as widely as possible, the SEA says it "envisages an electoral alliance of different parties, campaigning groups and individuals offering voters a radi-cal, anti-sectarian alternative to parties based on one or other of 'the two communities'

The SEA interventions in Foyle and East Derry showed that a credible, united left campaign can attract a level of support which cannot be derided or ignored.

Without a similar intervention, the Euro-pean election will be another sectarian headcount. But it will take a

united, broadly-based campaign to make a Left intervention credible.

The SEA has said that it wants to see a broad alliance covering the north and "are very open to argument from others as to how best we can jointly achieve this

However, if that cannot be achieved, they will go forward on their own with Eamonn McCann as a candidate.

Euro elections offer a chance to link dayto-day local concerns to major issues being fought out at European level.

National PRO of the Irish Anti War Movement Dr. Fintan Lane was released from Limerick Prison where he had been serving a 60 day sentence following his refusal to pay a fine for his part in a peaceful demonstration at Shannon Airport. Fintan Lane, the PRO of the Irish Anti-War Movement, has been in jail since 26th November because he refused to pay a 750 euro fine.

He was involved in a mass trespass at Shannon airport to protest at its use by the US military.

"What we did was an act of conscience and I have no regrets" said Fintan after his arrest.

"I couldn't pay this fine because that would be to plead guilty retrospectively and I will not do that. I feel no guilt for my actions.

"Innocent people are being killed in Iraq and Afghanistan by the war machine that is being facilitated at Shannon airport. What is happening is an outrage and it is no exaggeration to say that Fianna Fail and the PDs have blood on their hands".

NIPSA plan action
