CONCLUSION:

THAT ALL POLITICAL PARTIES FIGHTING FOR THE LIBERATION OF MOZAMBIQUE FROM THE YOKE OF PORTUGUESE IMPERIALISM, OPPRESSION AND COLCNIALISM SHOULD DISBAND AND FORM A MOZAMBIQUE REVOLUTIONARY COMMITTEE WITH NEW CONSTITUTION AND NEW LEADERSHIP.

All members of the set up committee accepted this idea except two members, and these were members of FRELIMO.

The conclusion, above, is and was not easy to reach at. It was after careful and reasonable consideration by all parties concerned that they concluded that the interest of Mozambique was supreme, above that of organization identity. All parties realised it was Monambique to serve and not party. They realised UNITY is important in the struggle to free Mozambique regardless of what name the united organization will be called.

It was in this spirit that after careful assessment of the situation in Mozambique all parties concluded that the only answer to the evils that plague Mozambique was UNITY, and in order to accelerate the liberation of Mother Mozambique, and indeed, Mother Africa, UNITY in SACRIFICE; UNITY in SERVICE; UNITY in SUFFERINGS; and UNITY in everything that would contribute to the freedom of Mozambieque was essential. Thus, all parties made concessions after concessions in the spirit of coming to a common understanding for UNITY. Finally, it was agreed that:-

"ALL PARTIES SHOULD DISBAND AND FORM A MOZAMBIQUE REVOLUTIONARY COMMITTEE WITH THE NEW CONSTITUTION AND NEW LEADERSHIP".

I must make it clear that Dr. Mondlane, President of FRELIMO emphatically refused the suggestion from three parties viz:

(1) UDENAMO (Mr. Gumane), (2) UDENAMO (MONOMOTAPA)(Mr. Gwambe) and (3) MANC (Mr. Simbi). FRELIMO felt that it was a big FRONT and there was no point in disbanding FRELIMO. They stood on their proposal that other parties should disband and join FRELIMO negotiations for positions will take place.

All means by other parties, including myself, to pursuade or appeal to FRELINO to look into the need for UNITY at present; to think twice over their conditions for unity; and to try to bring in suggestions or concessions so as to meet the other parties in one way or the other, failed entirely, so that the Committee was left in no doubt that only three parties were willing to unite on the condition laid down above. I therefore on behalf of the Committee set up yesterday report the conclusions of the Committee to this Conference for your opinion and final judgement.
