TO DETAIL THE CONDITIONS OF UNITY AGREED UP-ON _ BY

MOZAMBICAN NATIONAL LIBERATION MOREMENTS

- <u>CONSTITUTION</u> was drafted and agreed up-on by all members. Attached herewith is the draft condtitution.
- 2. <u>OTHER PARTIES</u> such as UNAMI and MANU should be asked to **join** the unity of three Mozambican National Liberation movements.
- 3. <u>DECLARATION OF UNITY</u>. It was agreed to make a declaration of UNITY signed by the three Organisations and with three signatures from each Organisation, and provided such . declaration, shall not be published to the press until fourteen (14) days after the day of signing the declaration.
- 4. <u>PRESS</u>. Nothing should be released to the press in connection with the UNITY talks until after fourteen days of the UNITY talks.

5. PREPARATORY COMMITTEE:

1.

- (a) In Order to ensure smooth Unification of the three Organisations, plus two which did not attend the UNITY talks, a "Preparatory Committee" shall be formed on 31st March, 1965.
- (b) The Preparatory Committee shall be composed of ten(10) members, two from each of the five Organisations.
- (c) The Preparatory Committee which shall be, on formation, composed of six members shall contact MANU and UNAMI of the two organisations among to send, immediately, two from each their members to serve on the Preparatory Committee.

- (d) It shall be in frequent contact with all the five Organisation;
- (e) It shall make negotiations with the Government of the Republic of Zambia on moral and material support in preparing for a Congress where laaders of COREMO shall be elected;
- (f) It shall contact other African Governments and the/ Liberation Committee for financial, material and moral Aid to the new organisation;
- (g) It shall be in contact with any Member of the five organisations by sending them resolutions, and other materials of this UNITY talks;
- (h) It shall draw the Agenda of the Congress;
- (i) It shall last until the week of 26th April, to 1st
 May, 1965, unless some emergent needs, for it to prolong its duties, arises
- (j) It shall work in the name of Mozambique Revolutionary Committee (COREMO);
- (k) It shall open Post Office Box and telegraphic address in the name of COREMO;
- It shall design and send for the printing of headed papers in the name of COREMO;
- (m) The following shall be Members of the Preparatory

MOZAMBIQUE UNITY CHARTER

"OUR COUNTRY NOW OR DEATH"

We, the sole accredited and faithful spokesmen of the true fighting forces of Mozambique National Liberation Movements who assembled from 24th to 31st March, 1965, in LUSAKA, REPUBLIC OF ZAMBIA, after analysing carefully the detrimental and revolutionary baseless misunderstandings which are the sources of the broaden divisions amongst the genuine and patriotic forces of Mozambique, do <u>DECLARE</u> that we come to-gether in <u>ONE UNITED BODY</u> to be known as <u>COMITE' REVOLUCIONARIO DE MOÇAMBIQUE</u> (COREMO), (Mezambique Revolut:ionary Committee) in order to eliminate and sink once and forever, all the detrimental and unfortunate misunderstandings and to fight unitedly, unequivocally, relentlessly and vigorously against tyrannical, dictatorial, inhuman and barbarous Portuguese regime in Mozambique. We, further, ardently <u>DECLARE</u> that:-

- We completely and unreservedly adhere to the prior responsibility of uniquely concentrating all our efforts solely on the total and unconditional National Independence of our country;
- 2. We vehemently condemn clogged sectionists and isolationists based practically on self-interests and paltry scattered groupings which in the contrary pave the avenue and success for our common enemies;
- 5. We, guided by previous experiences and prevailing conditions, resolve to disband all Mozambique National Liberation movements through <u>VIGILANT</u> TRANSITIONAL stages and replace them with the Comite' Revolucionario de Mocambique (COREMO) as the <u>SOLE</u> Pioneering Body which shall in all aspects direct the fierce fight against Portuguese imperialism colonialism and neo-colonialism in Mozambique;
- 4. We, unconditionally, invite all genuine patriotic forces fighting for the immediate and total National Independence of Mozambique to come forward and sincerely absorb themselves into the Comite' Revolucionario de Mocambique (COREMO) in order to bring to an immediate end the scuffle we are facing at present; and
- 5. One original Copy of this <u>MOZAMBIQUE UNITY CHARTER</u> shall be deposited with the Government of the Republic of Zambia till further notice and another original Copy shall be deposited

with the ATTICAN LIBERATION COMMITTEE of the Organisation for African Unity till further notice.
